Adjustments to the equity indices on 20 September 2010

Based on the criteria set out in the index regulations of the SIX Swiss Exchange (rules governing the SMI[®], SLI[®], SPI[®] and SXI[®] indices), the scheduled index adjustments will be conducted on 17 September 2010 after the market close and take effect as of 20 September 2010.

The final list will be published on 13 September 2010 prior to the opening. This allows any last-minute updates to be taken into account.

Index basket adjustments SLI[®], SMI[®], SPI[®] and SXI[®] Family

By means of [SIX Swiss Exchange message no. 55/2010](#) dated 7 July 2010, the definitive adjustments to the index compositions of the SLI[®], SMI[®], SPI[®] and SXI[®] Family have already been communicated.

Adjustment of capping factors SLI[®] and SXI[®] Family

For the SLI[®] as well as for the SXI[®] Family (sector Life Sciences), large capitalised securities will be capped again at 9% and 4.5% (SLI[®]) and at 10% (SXI[®]) on the basis of the closing prices of 10 September 2010. The capping factors will be published on 13 September 2010 prior to the opening in the list mentioned above.


